## **SECTION 3: Hazards Identification**

**EMERGENCY CASE:** skin burned when contacted with melted product

MEDICAL POTENTIAL EFFECT: At processing temperatures above 325 deg C, fumes irritating to the eyes, nose and throat may be evolved. Exposure may result in redness, itching and tearing of the eyes and soreness in the nose and throat together with coughing.

SKIN CONTACT: No data are available. However, based on experience with handling these polymers, no unusual dermatitis problem is expected from routine handling. Molten polymer contacting the skin will cause thermal burns.

EYE CONTACT: Mechanical irritation only.

**INGESTION:** Not a probable route of exposure. Toxicity is predicted to be low.

**Ventilation System**: In general, dilution ventilation is a satisfactory health hazard control for this substance. However, if conditions of use create discomfort to the worker, a local exhaust system should be considered.

**Personal respirators (NIOSH approved)**: For conditions of use where exposure to dust or mist is apparent and engineering controls are not feasible, a particulate respirator (NIOSH type N95 or better filters)may be worn. If oil particles (E.g. Lubricants, cutting fluids, glycerin, etc) are present, use a NIOSH type R or P filter.

For emergencies or instances where the exposure levels are not know, use a full face positive pressure, air-supplied respirator.
